Implementation of Blended Mode of Learning and "Quality Education Fund e-Learning Funding Programme—Provision of Mobile Computer Devices and Internet Services Support" (2022/23) 推行混合模式學習 及

「優質教育基金電子學習撥款計劃—流動電腦裝置及上網支援」(2022/23)

Our school has been implementing the "Bring Your Own Device" policy since the 2020/21 school year, recommending students to bring their own mobile computer devices to school for learning. To alleviate the financial burden of students from low-income families, we have participated in the "Quality Education Fund e-Learning Funding Programme—Provision of Mobile Computer Devices and Internet Services Support" to apply funding for purchasing mobile computer devices for loan to financially needy students.

Our school therefore would like to know whether students need to apply for related equipment. **Eligible students** are those who are

- 1. receiving Comprehensive Social Security Assistance (CSSA) from the Social Welfare Department, or
- 2. full/half grant of the School Textbook Assistance Scheme (STAS) from the Student Finance Office; or
- 3. students with **limited economic means** identified by schools. If students' families face financial difficulties but are not receiving CSSA or STAS due to special circumstances, they may provide schools with explanations or supplementary information. The EDB provides a limited amount of quota to our school for purchasing e-learning equipment for loan to needy students with genuine needs identified by school-based criteria.

Also, students who meet the above eligibility criteria and unable to acquire appropriate Internet services due to their living environment, they can use the "Subsidy of Internet Access Charges" (2022/23 school year) to acquire suitable Internet facilities (e.g. mobile data card) for elearning at home if they receive the subsidy. If the "Subsidy of Internet Access Charges" cannot cater for the needs of e-learning, parents can provide justifications to schools for having additional support.

All parents should complete the **reply slip** through **eClass eNotice System** by 21st September 2022. Students who would like to borrow the equipment should submit a **copy** of the **eligibility proof** (e.g. the letter of result notification) to the following **Google Form**. (*CSNO and student name should be written at the top right hand corner of the documents.)* In case students are **yet to be notified** of their CSSA or STAS application result, they should **complete** the **reply slip** by the aforementioned date and **submit** the letter of **result notification** from CSSA or STAS through the Google Form **by** 7th October 2022.

本校自 2020/21 學年起推行「自攜裝置」政策,建議學生自備流動電腦裝置回校進行學習。為減輕因學校發展「自攜裝置」政策對低收入家庭學生帶來的經濟壓力,本校會於今學年參加「優質教育基金電子學習撥款計劃一流動電腦裝置及上網支援」,申請撥款購買流動電腦裝置供有經濟需要的學生借用。

本校現向家長了解學生是否有需要申請借用相關設備,申請資格包括

- 1.正領取社會福利署的綜合社會保障援助(綜接)或
- 2.學生資助處的學校書簿津貼(書簿津貼)全額或半額資助。
- 3.如學生家庭有**實際經濟困難**,但基於特殊情況未有領取綜援或書簿津貼,可向本校提供說明或補充資料。教育局為本校提供有限的名額,讓學校可按校本準則,以幫助有真正需要的學生。

另外,合乎以上申請資格且因居住環境所限而未能獲得合適上網服務的學生,如有領取「上網費津貼」(2022/23 學年),可使用該津貼購置合適上網設備(例如購置流動數

據卡),以便在家中進行電子學習。如「上網費津貼」未能照顧電子學習上需要,家長可提出理據以便學校提供額外支援。
