'Susceptibility to Scam Assessment' (Secondary 1-5)

「詐騙易感性評估」(中一至中五)

The Anti-Deception Alliance (Education) has invited our school to conduct a 'Susceptibility to Scam Assessment' for students in early April. This initiative aims to ensure the safety and well-being of our students, considering the widespread nature of scams that affect individuals of all ages.

Susceptibility to scam refers to an individual's tendency to become a victim in specific scam scenarios. Factors that may contribute to victimization include students' behaviors, perceptions, attitudes, exposure to real-life scams, and reporting behaviors. The assessment aims to gather authentic opinions and experiences from students, which are invaluable for the research. Students will not be asked for any personal information and their individual responses will remain confidential.

The assessment is expected to take approximately 5 minutes to complete. All assessment data and participant responses will be securely stored and managed by the Division of Life Science at the Hong Kong University of Science and Technology, solely for research and strategic purposes related to scam risk management in schools and the education sector.
